- 1. The invitation is open to all genuine firms/ dealers located based in Delhi/NCR only who are having PAN/VAT/GSTIN registration in their name. (copy of PAN,VAT,GSTIN registration and authorization certificate must be enclosed with tender documents.)
- 2. Firm/Dealer should have at least 02 years experience with Government offices in supplying such IT items
- 3. "Quotation for Microsoft Windows Server 2012" should be written in block letters on the top of the Envelope.
- 4. PLEASE SUBMIT EMD (EARNEST MONEY DEPOSIT) FOR AN AMOUNT OF RS.10000/-(RUPEES TEN THOUSAND ONLY) IN THE FORM OF DEMAND DRAFT IN FAVOUR OF Pay & Accounts Officer (Secretariat), MoES, New Delhi, QUOTATIONS WITHOUT EMD SHALL BE LIABLE FOR REJECTION.
- 5. In case the supplier is not able to supply goods for which supply order has been placed within the stipulated time of supply order, the supply order shall be cancelled and earnest money deposit by supplier of Rs. 10000/- shall be forfeited.
