1. **Page no.5** of EOI cum limited tender Document: As per the request received from the potential Prime bidders during the Pre-bid meeting held on 28th January 2019, **the last date of submission of the tender bid online through as well as in a hardcopy is extended up to 14th March 2019 at 17:00 Hrs. and Date of Bid opening is 15.03.2019 at 11:00 Hrs.**
2. **Page No. 14** of EOI cum limited tender Document, column no. 13.1: 9th Line no: “The mobilization advance as above shall bear a simple interest at the rate of 18% per annum calculated from the date of payment to the date of recovery, both days inclusive, on the outstanding amount of advance” may be read as “The mobilization advance as above shall bear a simple interest at the rate of 18% per annum calculated from the date of payment to the date of recovery, both days inclusive, on the outstanding amount of advance **in case of failure in delivering the work as per MoU signed between NCS-MoES and the qualified Prime Bidder (s).**”
3. **Page No. 28** of EOI cum limited tender Document, Table no 3 (Category III):item no. 1c “Drilling (with Hydraulic rig only) and rock core sampling, Rock classification in terms of RQD, [IS:11315 pt. 11-1985] up to 3m of rock strata if encountered within 30 m depth” may be read as “**Drilling (with Hydraulic rig only) and rock core sampling, Rock classification in terms of RQD (75%), [IS:11315 pt. 11-1985] up to 3m of rock strata if encountered upto 30 m depth**”.

4. **Page No 35**, of EOI cum limited tender Document, Table No 5 (category V): In Description of work: “Micro-tremor Survey for H/V Analyses using Ambient noise” Quantum of work “In a grid pattern of 500m x 500m preferably using Broadband Seismometer” may be read as “In a grid pattern of 500m x 500m preferably using Broadband Seismometer **with at least 2-hours observation at single site excluding stabilization time (~20 min)**”.

5. **Page No 36**, of EOI cum limited tender document, Table no 6 “Final complete Report/ Reports with maps in A0-size must be submitted to NCS-MoES by the Prime Bidder. The report must contain all layered information in GIS-based format along with their prints. Report must contain submission of hard and soft copies of the report and data files, processed records, maps, interpretational details of results need to be submitted to NCS-MoES by the qualified Prime Bidder on completion of the investigation of the city / cities”. It may be noted that complete Report/ Reports with maps in A0-size must be submitted to NCS-MoES by the Prime Bidder with all layered information in GIS-based format along with their final prints. Report must contain submission of hard and soft copies of the report and data files, processed records, and maps. All rock sample collected during field survey must be submitted to NCS-MoES after completing the laboratory analysis of the rock samples and interpretational details of results also to be submitted to NCS - MoES by the qualified Prime Bidder on completion of the investigation of the city / cities. **Entire data, interpretation, reports and related documents as well as rock samples are the property of NCS-MoES, which need to be protected with utmost confidentiality, without their sharing of which “No Publication” allowed as per approved RFP.**

6. **Page No. 15**, of EOI cum limited tender Document, column no **13.2**, “On adjustment of given advance after submission of utilization certificate by the Prime Bidder, the rest payment of 90% amount of the total value of the contract will be made in four equal installments (22.5%) for the project duration of 1- year / 2-years only after the satisfaction of NCS-MoES on the progress of the works as per the guidelines for

conducting the requisite investigations and submission of utilization certificate of the previous paid value, out of which the last installment will be released after submission of final report that completed in every aspect dealing with investigations of the city to NCS-MoES by the concerned Prime Bidders for the concerned city” may be read as “On adjustment of given advance after submission of utilization certificate by the Prime Bidder, the rest payment of 90% amount of the total value of the contract will be made in four equal installments (22.5%) for the project duration of 1- year / 2-years only after the satisfaction of NCS-MoES **on the progress of the works based on receipt of quarterly report from the prime bidder (s) as per the guidelines for conducting the requisite investigations and submission of utilization certificate of the previous paid value**, out of which the last installment will be released after submission of final report that completed in every aspect dealing with investigations of the city for NCS-MoES by the concerned Prime Bidders of the concerned city.

7. Page No.3, The partner organisation(s) name(s) need to be informed by the Prime Bidders to NCS-MoES along with their technical bids may be read as “The partner organisation(s) name(s) need to be informed by the Prime Bidders to NCS-MoES along with their technical bids. **This is also to be noted that selection of the partner or partners /Associate or Associates by the concerned prime bidder is the prerogative of that prime bidder (s) based on their own judgement criteria for selecting the partner, partners /Associate, or Associates for completing the specified work as per the approved RFP. Partner or partners/Associate or Associates can be associated with any number of prime bidder or bidders as NCS-MoES is only concerned to deal with qualified prime bidder(s) only regarding completion of the quality-work**”.
