**Comprehensive Annual Maintenance Contract**

Subject: **Limited Tender Enquiry for full Comprehensive Maintenance Contract for Photocopier machine (different make) for 2 years.**

Sir,

Ministry of Earth Sciences invites Sealed Bids for award of full Comprehensive Maintenance Contract Annual Maintenance Contract (CAMC) of different mode/make photocopier machines as per Annexure – A for a period of 2 years.

1. Interested firms may send their quotations in a sealed cover super – scribed “Quotation for full compressive annual maintenance contract of photocopier machines” in the format as given is Annexure – B [Superscribed as “Technical Bid] and Annexure – C [Superscribed as “Financial Bid’] which should be dropped in tender box or before 3.00 pm on 29/12/2015 kept in **Room No. 01, Ground Floor, Ministry of Earth Sciences, Prithvi Bhavan.** The sealed quotations are to be addressed to Section Officer (General), Ministry of Earth Sciences, Prithvi Bhawan, Lodi Road, New Delhi – 110003. The tenderers have to submit an EMD of Rs.10,000/- in the form of Account payee Demand Draft from any commercial bank drawn in favour of the DDO, Ministry of Earth Sciences. The tender will be opened on same day at 3.30 PM in the presences of the bidders or their representatives who may like to be present.

2. The rates may be quoted on the basis of meter reading (per page) for full comprehensive annual maintenance contract. Full comprehensive annual maintenance contract on regular basis including toners, all spare parts and consumables items required on repairing. If the services of the firm are found satisfactory, the AMC can further be extended as on the same rates and same term and conditions.

3. The EMD of Rs.10,000/- in the form of a Demand Draft payable to DDO, Ministry of earth Sciences, is required to be submitted. The said earnest money will not bear any interest. The earnest money of unsuccessful tenders would be returned without any interest after completion of tender process.

4. The repair/servicing work etc. would be carried out in the premises of the Ministry. Only such repair which cannot be undertaken in the office premises will be allowed to be done outside with the written permission of US (GA) and for this propose no extra payment would be made. No transportation charges will be paid by the Ministry.

5. The Ministry of Earth Sciences also reserves the right to reduce or increases the number of photocopier machines offered for comprehensive Maintenance, and rates will be paid on pro – rata basis for any much increase or decrease.

6. The firm will have to depute a qualified Engineer who should have knowledge of the repair work of different make photocopier machines on call basis. Such visits on call should be very prompt and the Engineer should visit this Ministry within 3-4 hours after a telephone call is made for repairing a fault. In case the call is made late in the afternoon, the Engineer should visit this Ministry early morning next working day.

## **7. Eligibility Criteria**

i) The firm should have minimum 3 years experience of work with the Government / Public Sector undertaking or companies of repute. Performance certificate from the existing Govt. or other Clients must be attached.

ii) The firm should have Average Annual Turn over of atleast Rs.5 lakhs during the last 3 years (Documentary evidence should be enclosed).

iii) The firm must be registered under the relevant Act/Rule and it should possess registration number from the Delhi, Sales Tax Department (Vat No.)/ Service Tax Department (Photocopies must be attached).

iv) The firm must have Multi OEM product support capability i.e. to under take AMC of photocopier brands of Toshiba/ Canon/ Ricoh etc. and shall act as a single point of support contract for all products.

v) The firm should provide only genuine parts of various brands of photocopier machines.

vi) The firm should be an Original Equipment manufacturer (OEM) authorized service provider of any or all brands of Photocopiers like Ricoh/ Toshiba/ Canon/ etc. and copy of authorization (current dated) in this regard should be submitted. Tenders of non-authorized firms shall be rejected.

## **8. Other Terms & Conditions.**

i) The Service Tax will be paid as per rules and as amended from time to time.

ii) The earnest money of the successful tenderer shall be returned on submission of performance security equal to 5% of the contract value for two year in the shape of Fixed Deposit Receipt (FDR)/Bank Guarantee shall be provided by the firm. The performance security should be furnished within one month of awarding the contract with validity beyond 60 days of the expiry of the contract.

iii) In the matter of any dispute between the parties regarding the terms and conditions of the contract and execution thereof, the matter shall be referred to Arbitrator(s) as may be decided by the Secretary (MoES)/JS(A) for Arbitration under the Arbitration & Conciliation Act, 1986. The firm or contractor shall not question the decision of arbitrator(s) on the ground that Arbitrator(s) is/are Government Servant(s). The decision of Arbitrator(s) shall be final and binding on the parties.

- iv) Finally short listed vendor shall be required to enter into a written AMC agreement with MoES for honoring all tender conditions and adherence to all respects of fair trade practices for AMC awarded by MoES.
- v) The vendor should have a good reputation in field. The vendor should have a good presence in the jurisdiction of the Delhi and should provide support from their local offices by deputing resident engineers from 9.00 a.m. to 5.30 p.m. at the above designated customer site, wherever required. In case of emergency, the engineer may be required after office hours and on holidays also.
- vi) All the complaints / repairs would be rectified within – 24 hours from the time of the complaint as noted in a Register kept in section failing which a penalty of Rs. 500/- per working day will be deducted from the invoice limited to. In case the complaint is not attended to even a lapse of 5 days, agreement can be cancelled and performance security can be forfeited.
- v) The Comprehensive AMC billing shall be done on quarterly basis after completion of three month. No advance payments will be made in any case. The firm will strictly maintain separate logbooks for each of the machines to be taken under the AMC.
- vi) The firm shall maintain the equipment as per manufacture's guidelines and shall use standard components for replacements. Until and unless written order of US (GA) is conveyed, the original specification/characteristics/ features shall not be changed.
- vii) All disputes are subject to the jurisdiction of Delhi Courts.
