Earnest Money Deposit

- 1. An Earnest Money deposit (EMD) of Rs.50,000/- (Fifty Thousand Only) in the form of Account Payee Demand Draft/Fixed Deposit Receipt (FDR)/ Bankers's Cheque or Bank Guarantee from any of the commercial banks will be required to be submitted along with the Technical Bid. The EMD may be drawn in favour of Drawing and Disbursing Officer (DDO), Ministry of Earth Sciences, New Delhi payable at Delhi and MSME Registration. The Bids received without the EMD or valid bid exemption certificate (as per GFR/Govt. instructions) will not be considered for further evaluation will be rejected and MSME Registration will not be considered as valid (No Exemption of EMD will be allow in any case). The EMD of unsuccessful bidders will be returned after award of Contract and the EMD of successful bidders will be returned only after receipt of Performance Security.
- 2. In place of bid Security (EMD), the firms can be submit a declaration (as per Annexure V) that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids documents or award letter, they will be suspended for the period of 2 years from being eligible to submit bids for contract with this Ministry.

Forfeiture of EMD

The EMD shall be forfeited:

- a) If the bidder withdraws his bid during the period of bid validity.
- b) In the case of successful bidder, if he fails to furnish the required Performance Guarantee within

the specified time limit.

Performance Security:-

1. The successful bidder shall be required to deposit a sum of Rs.2,00,000/- (Rupee Two Lakh only) as Performance Guarantee in the form of Fixed Deposit Receipt (FDR) or Bank Guarantee drawn in favour of DDO, Ministry of Earth Science and payable at New Delhi within 21 days of the issue of award letter. The same would be refunded after 60 days from the successful completion of all the contractual obligation of this Tender/Contract.

Eligibility Criteria:-

- i) The Bidder should have average Annual Turnover of Rs.50 Lakhs during the last three financial years. Copies of Audited statement of accounts or a certificate from chartered accountant may be enclosed.
- ii) The Bidder must have filed Income Tax Return of Last Three financial years. Copies of documentary proof of the same must be enclosed.
- iii) The Bidder must submit an undertaking that they have not been blacklisted by any State/ Central Government/ PSU in India.
- iv) The firm should have successfully completed 1 similar works costing not less than Rs. 12,00,000 /- Lakhs in the last three years.

OR.

Having successfully completed 2 similar works costing not less than Rs.9,00,000/- Lakhs per year in the last three years.

Note: - Similar work means work relating to repairs works of furniture, plumbing and masonry items in State/ Central Government/ PSU in India.

v) The Bidder should have experience of working with Government organization during last three years. Copies of work order received from them should be enclosed as proof received along with completion certificate.

Selection Criteria: The bidder who meets the Eligibility Criteria mentioned above and quotes the overall lowest rate shall be awarded the Tender. In case of tie, the firm which has more experience shall be awarded the contract. The decision of the Tender Committee shall be final in this regard.

Instruction for Financial Bid

- i) Overall Percentage (above/below) on the CPWD (DSR) rates are to be quoted for supplying and fixing (including labour charges) 2016 in financial bid, excluding taxes as applicable.
- ii) Any item which is not listed in CPWD DSR manual will be taken at market rate and contractor profit of 10% on the market rate shall be payable.

Other Terms & Conditions

- 1. The bidder should enclose a detailed profile of firm including details of their product and service.
- 2. All pages of the tender document and all enclosures should be serially numbered and signed by the bidder on each page as a token of acceptance of all Terms & conditions of the Tender Document.
- 3. The <u>Ministry reserves the right to reject any quotation</u> in whole or in part without assigning reason thereof.
- 4. It may be noted that if a single bidder, who has not quoted L1 prices for all items, is not found then the bidder who has quoted the overall lowest rate will be awarded the Tender.

5. <u>All material of ISI mark and good quality of services of the repair work are required to be supplied by</u> the Tenders themselves, to the best of satisfaction to this Ministry.

6. The successful vendor is bound to attend the work/works at Ministry within 6 hours, except emergencies, after being informed by the Ministry.

- 7. In case the call is not attended by the Contractor within 24 hrs, a penalty of Rs.500/- per day to be decided by the Ministry of Earth Sciences will be levied upon the Contractor after due verification from the user/department.
- 8. The Successful vendors rates quoted will be valid for two years (i.e. during duration of the contract) The rates will be valid for two years from the date of issue of work order, which can be extended for another two years on the same rates, terms and condition if work is satisfactory. The Ministry of Earth Sciences shall however have the right to terminate the contract at any time without assigning any reason thereof.
- 9. The work is to be carried out in the premises of the Ministry of Earth Sciences New Delhi. Only such work as cannot be done in the Ministry premises would be allowed to be done outside and no extra charges to be paid by Ministry on account of transportation etc. The material items for repair can be taken outside only on the written permission of the Section Officer (GA) of this Ministry.
- 10. The Ministry of Earth Sciences can terminate the contract at any time without assigning any reason, if the work of the contractor is found unsatisfactory; In this respect the decision of the Ministry will be final and binding on the contractor.
- 11. In the matter of any dispute between the parties regarding the terms and conditions of the contract and execution thereof, the matter shall be referred to Arbitrator(s) as may be decided by the Secretary/JS(A), (MoES) for Arbitration under the Arbitration & Conciliation Act, 1996. The firm or contractor shall not question the decision of arbitrator(s) on the ground that Arbitrator(s) is/are Government Servant(s). The decision of Arbitrator(s) shall be final and binding on the parties.
- 12. The work is required to be carried out in restricted area, proper passes are to be got made from security officer for workmen/contractor deployed for the same.

Instructions for Online Bid Submission:

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- 1. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <u>https://eprocure.gov.in/eprocure/app)</u> by clicking on the link "**Online Bidder Enrollment''** on the CPP Portal is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sift' /TCS/nCode/eMudhra etc.), with their profile.
- 5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1. There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 2. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. PREPARATION OF BIDS

- 1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option which in reducing size of the scanned document.
- 4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other important Documents" area available to them to upload such documents. SUBMISSION OF BIDS

- 1. Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3. Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable **and** enter details of the instrument.
- 4. Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the Tender Processing Section, latest by the last date of bid submission or as specified in their tender documents. - 5. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable.
