The point-wise reply is as under:

A proposal dated 30.11.2012 was received in the Ministry on 1. 24.1.2013 from the Mata Rukhaminbai Sevabhai Sanstha, Nagzari Ambaogai, Distt. Beed, Maharashtra for organizing a seminar on "Climate Change and Oceans" on 1st and 2nd October, 2013 at Mata Rukhaminbai Sevabhai Sanstha, Nagzari Parisar, Shepwadi, TA. Ambajogai, Distt. Beed, Maharashtra.

In this regard, a letter was written by the Ministry to the Member Secretary, Rajiv Gandhi S&T Commission, General Administration Department, New Administrative Building, 18th floor, Madam Cama Road, Mumbai, Maharashtra on 18.3.2013 with a request to verify the authenticity of the Society and its activities and relevance to the said proposal.

As and when the Ministry receives a reply to its communication dated 18.3.2012, the proposal will be processed for consideration of the Committee on Seminar and Symposia.

2. The Ministry has so far not approved the proposal for holding the seminar for want of verification from the Rajiv Gandhi S&T Commission, Mumbai.
