



1	Kindly give me the details of promotion avenue for some scientist of Mathematics. Computer Science and statistics were stopped in scientific organization like Ministry of Earth Sciences, DST and CSIR in their mid career.	Matter is under consideration with DoP&T and no final decision has so far been taken, therefore, no material information exists at this stage for disclosure. The definition of information, as it occurs in Section 2(f), lays down the scope of the type of information a petitioner can seek. It is not open to an appellant to ask, in the guise of seeking information, questions to the public authorities about the nature and quality of their actions.
2.	Kindly give me the date wise details of the avenue for promotion/career growth for such officers in Mid careers.	
3.	Kindly give me the date wise details of legal support to stop or diminish the promotion of scientist in mid career of these officers were recruited through UPSC or independent recruitment board having certain recruitment rules and promotion avenue.	
4.	Officers with Mathematics, Computer Science & Statistics etc background are getting promotion in other organization like NIC, DRDO, ISRO inspite of such ban. Then kindly give me the reasons of discrimination for MoES, DST & CSIR like scientific organization.	
5.	Kindly give me the remedial action for such type of discouragement for young scientist in primer scientific institutions.
