KS Subramaniam was subsequently relieved after certain deliberations from DoPT on date 26/10/2015 and has sought the information which is as under:-	A copy of D.O. letter No. MoES/Secy/12/2015 dated 7/12/2015 written by Secretary, MoES to Secretary, MNRE is enclosed.  As regards the other letter
"It is learnt that Secretary/Earth Sciences Dr. K Vijayraghwan wrote a letter (say, letter A) to Secretary/MNRE to request retaining or allowing working of KS Subramanim in Earth Sciences Ministry only (thus defying above orders of DoPT in letter and spirit). The letter was duly replied (say, letter B) by Secretary/MNRS not acceding to above request.
