I am directed to bring to your advice that the competent authority viz. Secretary/MoES, in order to bring in enhanced performance and better career progression for the Scientists and the administrative staff of MoES institutions, has approved that, no personnel of the Scientist stream in ordinary course be assigned administrative works such as general administration, accounts, internal audit, stores, contracts, establishment etc., which are to be essentially manned by personnel from the administrative stream (whether through permanent staff or by staff taken on deputation/ contract). In case of exigency, if administrative works are assigned to Scientists, it should be a purely temporary measure for <u>not more than six months</u> at a stretch and such a charge if given should be <u>additional to the scientific work</u> that ought to be carried out. Scientists involved completely in administrative works shall therefore not be screened in for assessment to the next higher grades under MFCS. Part B of the assessment proforma for MFCS with necessary revision is attached.
