1) Kindly provide a copy of (i) DoPT Establishment (Pay) Division advice vide their ID Note No. 2603/Secy(P) dated 13.10.2012 and (ii) Department of Pension and Pensioners' Welfare advice vide their Om No. 38/12/2013-P&PW (A) dated 23.8.2013.	The applicant may be asked to deposit Rs. 6/- (3 pages - A4 Size - @ Rs. 2/- per page) for providing the copy of DoPT advice vide their ID Note No. 2603/Secy(P) dated 13.10.2012 and Rs. 4/- (2 pages - A4 Size - @ Rs. 2/- per page) for providing a copy of Department of Pension and Pensioners' Welfare advice vide their Om No. 38/12/2013-P&PW (A) dated 23.8.2013.
2. Kindly inform the number of months over which the DDO, Cash & Accounts Section, MoES was advised to recover @ Rs. 85,000/- per month to redeem overdrawn pay and allowances. The notification is incomplete in this regard.	Copies of the correspondence and noting sides of the file related to the concerned order will be provided after receipt of Rs. 6/- (3 pages - A4 Size - @ Rs. 2/- per page) from the applicant.
3. Kindly provide a copy of the work sheet used to arrive at the recovery rate of Rs. 85,000/- p.m.	
4. It is stated in the above notification that "2. Dr. Shailesh Nayak, Secretary, MoES will continue to draw the Dearness Relief on pension sanctioned by Department of Space". Kindly inform whether Dr. Shailesh Nayak had been drawing the Dearness Relief on pension sanctioned by Department of Space until the issue of this notification.	Dearness relief on pension is paid as per extant GoI norms. Information on this aspect available with MoES is as per above point 2, 3. Further information, if any desired, may be received by approaching CPIO, DoS.
5. Kindly inform the names of the officers on whom departmental/criminal action is considered for overpayment as required by item 3(iii) of the DoPT OM F. No. 18/26/2011-Estt. (Pay-I) dated 06.02.2014.	Said DoPT OM item deals with the issue of excess payment made to an employee on account of fraud, misrepresentation, collusion, favoritism, negligence or carelessness etc. It is stated that it is not applicable in the case of Dr. Shailesh Nayak as excess payment to Dr. Shailesh Nayak occurred because of MoES's interpretation of recruitment conditions of

	Dr. Nayak relying on the fact that the said ACC communication did not mention re-employment per se. Advice of DoPT and DoP&PW, being the nodal departments was therefore sought on the matter and after receipt of necessary clarification, re-fixation and consequent recovery overdrawn pay of Dr. Nayak was carried out.
6. Kindly inform the interest rate charged in this case for the overdrawn pay as required by item 3 (vi) of the DoPT OM F No. 18/26/2011-Estt (Pay-I) dated 6.2.2014. In case of waiver of interest, kindly provide copy of approval for waiver of interest along with the name and designation of the competent authority.	Information on this aspect available with MoES is as per above point 5.
7. Kindly provide a copy of similar notification ordering reduction in pay and recovery of overdrawn pay and allowances during the tenure of as Director, INCOIS. It is understood from Office Order No. MoES//2/5/542011-Estt. dated 29.5.2013 that Director (Estt.), MoES is responsible for all works related to Establishment of Autonomous organizations also.	For autonomous organizations of MoES, ministry looks into those aspects only that are to be dealt at the level of the government. Issues as being brought forward in the present RTI application (pay fixation etc.) fall in the realm of the administration of the concerned autonomous organizations. Information regarding such issues may be thus received by approaching CPIO, INCOIS.
8. Kindly provide the names on INCOIS officers on whom departmental criminal action is considered for the over payment as required by item 3 (iii) of the DoPT OM F No. 18/26/2011-Estt (Pay-I) dated 6.2.2014.
