In this connection it is found that the SFS Note forwarded by IMD to MoES has not been examined earlier and the said SFS file is found to be not traceable in the Establishment Section.

- The Ministry is therefore examining the issue raised by IMD in their SFS Note as per extracts of SFS Note provided by Shri. J.K. Sharma, Scientist 'D' in his RTI application. IMD is requested to place on record the following facts and orders:-
  - It may please be confirmed whether all the three scientists were on official ex-India deputation or they were on ex-India training. Relevant orders in this regard may be furnished;
  - Specific government orders as mentioned in para 6 of the SFS Note
  - This may clarified as to why the assessment of these officials was not ii. conducted through the other medium of telephone /skyp /telepresence 111. specific reasons may please be furnished..
  - It may please note that the in-situ promotions governed by Flexible Complementary Scheme guidelines are linked to performance and specified residency period with no linkage to occurrence of vacancy. As such, concept of seniority/notional seniority does not appear to be applicable in MFCS.
    - However, in order to have considered views / advice of DoP&T (Estt.'D'/RR) Divisions, IMD is requested to forward a comprehensive self contained proposal with the supporting documents for further necessary action please.
