The meeting of the Screening Committee constituted with the approval of Chairman ESSO & GC was held on 11th July, 2012 in Ministry of Earth Sciences for Screening of the applications received for the post of Scientist 'C' as Post Code - 09 for ICMAM, Chennai and CMLRE, Kochi.

2. The Committee has considered in all ¹⁹²~~184~~ (one hundred ^{and ninety two}~~and ninety four~~) applications received for this purpose and also noted the last date of receipt of ~~online~~ applications was 26th May, 2012. The hard copy was to be sent latest by 2nd June, 2012 and for remote area by 9th June, 2012. 04 applications were received late and therefore, were not considered. In addition, the applications where the candidate had applied on line but not submitted any hard copy have also not been considered for want of authenticity of information given. Similarly, the applications not complete in respect of attachments like proof of age, qualification, experience etc have also been rejected. The details are at Annexure-I & II.


3. After screening the applications, the Committee has recommended that interview/personal talk may be conducted for the candidates as per Annexure-III

5. The committee has adopted the following criteria for screening and recommending the candidates for personal talk/interview


- a) In addition to essential qualification, Ph.D in relevant field as per the desirable qualification
