- 1. Kindly provide a copy of the complete noting made to the "competent authority" and also the approval of the competent authority.
- 2. Kindly provide a copy of the document which empowers the competent authority" to override the DoPT provision above.
- 3. DoPT OM No. 11013/6/94-Estt. (A) dated 27.5.94 unambiguously delineates that only "the Ministry of Personnel, Public Grievances & Pensions and the Ministry of Finance are the nodal Ministries responsible for formulating policies and framing rules and regulations relating to service conditions and other aspects of personnel administration of Government servants" and that "it is enjoined upon all Government servants that they should faithfully implement the laid down policies, rules and regulations, etc. in service matters". Kindly provide a copy of the OM if any for the Ministry of Earth Science to ignore the rules prescribed by DoPT.
- 4. Kindly inform the Pay and Allowances fixed for Dr. S. Rajan at the time of joining NCAOR as he must have resigned from Government Service before joining NCAOR and will be governed by "Pay fixation Rules of Reemployed Pensioner" as per DoPT rule cited above.
- 5. Kindly inform if Pay and allowances of Dr. Shailesh Nayak (Director, INCOIS, May 2008-August 2008), Dr. SC Shenoi, Director INCOIS and Dr. Rasik Ravindra, Former Director, NCAOR were fixed as per the DoPT rules cited above.

1,2 &3. The applicant may be asked to deposit Rs. 6/- (3 pages – A4 Size - @ Rs. 2/- per page) towards cost of providing information.
