 - The design for 2 nos. of 1 million liters per day capacity LTTD plants in the premises of the Tuticorin Thermal Power Station (TTPS) for desalination using condenser reject waste heat is ready.
 - Detailed Project Report (DPR) for a 10MLD capacity offshore desalination plant has been prepared with industry participation.
 - There is also an attempt to put up 6 more LTTD plants in Lakshadweep Islands.
