2. The requisite information point-wise as sought by the Applicant under RTI, ACT,  
2005 is as under:
  - i) MoES received representation dated 5.3.2013 and dated 6.3.2013 from Dr. Anju Pandey  
addressed to Secretary, MoES and comments of Director, NCAOR were called vide MoES  
Letter dated 18.3.2013. It is found that NCAOR provided their comments to the Ministry  
vide their letter dated 3.5.2013, which came to the knowledge of MoES at the time of  
perusal of reply prepared by NCAOR in O.A. No. 500/2013(Dr. Anju Pandey Vs. MoES).  
Since, no communication dated 3.5.2013 from NCAOR was received by the Ministry  
before, no action was taken.
  - ii) MoES received representation dated 7.3.2013 from one Shri GP Naik addressed to  
Secretary, MoES and comments on the contents of the letter had been called from NCAOR  
on 09.04.2013. No actionable issue was seen (after going through comments of NCAOR)  
at the level of Ministry and hence no action was taken.
  - iii) MoES received same representation dated 7.3.2013 from one Shri GP Naik addressed  
to Chairperson, National Commission for Women(NCW), New Delhi which was  
forwarded by Ms. Shamina Shafiq, Member, NCW to Secretary, MoES. Ms. Shamina  
Shafiq, Member, NCW was apprised of the matter as per comments of NCAOR.
  - iv) MoES received same representation dated 7.3.2013 of Shri GP Naik addressed to Smt.  
Meira Kumar, Hon'ble MP which has been forwarded by Sh. Md. Aftab Alam, Dy.  
Secretary, Committee of Petitions Branch, Lok Sabha Sectt. to Secretary, MoES for para-  
wise comments. Sh. Md. Aftab Alam, Dy. Secretary, Committee of Petitions Branch, Lok  
Sabha Sectt has been apprised of the matter after seeking comments of NCAOR vide letter  
dated 24.9.2013.
