Please provide me the following information/documents under RTI Act, 2005; I am a bonafide citizen of India.

- (1) The number of officers/officials working in Central Secretariat who visited Nathu La after the conversion of Home Town LTC to North East was allowed, Ministry/Department-wise, be intimated.
- (2) The details of payment/re-imbusement made to each of the officers/officials for journeys performed during LTC from Bagdogra/New Jalpaiguri to Nathu La via Gangtok, Ministry/Department-wise, be provided.
- (3) The standard rate of payment for performing journeys to places in the state of Sikkim not connected by public transport may be intimated.
- (4) A certified copy of guidelines issued by DoP&T for the purpose of dealing with LTC cases relating to NER, including Sikkim, be provided.
